CWA LOCAL 1038 SCHOLARSHIP Frequently Asked Questions:

- What happens if my application is not submitted by the due date?
 It will not be accepted. All applications must be submitted to 451 Glassboro Rd., Woodbury Heights, by 4:00 pm on the due date.
- 2. What happens if I'm waiting on additional information for my application? Only complete applications will be considered.
- 3. Who is eligible for the scholarship? CWA 1038 members, spouses, children and dependents with verification.
- 4. Am I eligible for the scholarship if I attend trade school? Yes, you are, please apply!
- 5. Who will the check be made out to?

 The check will be made out to the recipient of the scholarship award.
- 6. Do I need to attend the membership meeting to receive my award and check? We strongly encourage that you or a designee attend. If unable to attend, please notify the scholarship committee.
- 7. What if I have questions about the application?

 Contact the numbers listed at the bottom of the scholarship form.
- 8. How will I know if I received a scholarship award?

 You will be notified by the email address on the application. Awardees will be posted on the CWA 1038 web site. Awardees will need to submit their social security number to receive their check.
- 9. What if I am not selected for the scholarship?
 You will be notified by mail. You are encouraged to apply again next year.
- 10. Can I be awarded a scholarship more than once?

 No, prior recipients are not eligible.
- 11. Can more than one family member apply for a scholarship?
 Yes, more than one member may apply as long as they meet the requirements.
